Administrative Recommendation	Administration recommends that Council give second and third readings of Bylaw 1576/22 to authorize the use of long-term borrowing to fund the reconstruction of Range Road 234 from Township Road 560 to Highway 28.

Report	<p><u>Background Information</u></p> <ul style="list-style-type: none"> • Range Road 234 is a collector road with connections to the Nywenning Subdivision and other area residents. • Range Road 234 was identified as the next candidate for reconstruction based on the collector reconstruction program prioritization criteria. • The Range Road 234 Reconstruction Project was first presented and approved as part of the 2021 Capital Budget, and later presented and approved again as part of the 2022 Capital Budget. • The full anticipated project cost for the Range Road 234 reconstruction project is \$5,232,000. The proposed Debenture Bylaw 1576/22 is for

	<p>\$890,000, which is 17% of the anticipated project cost. \$3.87 million in municipal reserves and \$0.47 million in grant funding provide the remaining funds for the project.</p> <ul style="list-style-type: none"> • Debenture funds will be drawn in accordance with the Debt Management Policy. • The tax-supported debenture is a 15-year term with semi-annual interest payments. The total interest on the life of the debenture is approximately \$231,246 and the annual payment is approximately \$74,750. • Sturgeon County's debt limit as of December 31, 2020 per the <i>Municipal Government Act</i> (MGA) is \$125,608,454. • The total outstanding debt principal as of December 31, 2020 is \$34,229,692 (audited). • Sturgeon County's debt limit as of December 31, 2021 per the MGA is projected to be \$145,594,196 (unaudited) with total long-term debt principal anticipated to be \$30,866,852 (unaudited). • Based on the 2021 projected debt limit and debentures approved by Council for 2021, the debt limit available based on MGA regulations is \$107,427,344. <p><u>External Communication</u></p> <ul style="list-style-type: none"> • Following first reading of Bylaw 1576/22 on January 11, 2022, advertisements were placed in the Morinville <i>Free Press</i> and Redwater <i>Review</i> for two consecutive weeks starting January 19, 2022. There were no petitions of the electors for a vote on Bylaw 1576/22 during that time. The public notice was also posted on the Sturgeon County website. • If Council passes Bylaw 1576/22, it will be published to the Sturgeon County website. <p><u>Relevant Policy/Legislation/Practices:</u></p> <ul style="list-style-type: none"> • <i>Municipal Government Act</i>, RSA 2000 c.M-26 • Debt Management Policy
<p>Implication of Administrative Recommendation</p>	<p><u>Strategic Alignment:</u></p> <p>Operational Excellence – Reconstructing Range Road 234 from Township Road 560 to Highway 28 will ensure travel is safe and services are easily accessible for residents of the Nywenning subdivision and surrounding area.</p> <p><u>Organizational:</u></p> <p>Administration will implement the Range Road 234 Reconstruction Project through the 2022 capital plan.</p> <p><u>Financial:</u></p> <ul style="list-style-type: none"> • The Debenture Bylaw request is for \$890,000. • The current interest rate for a 15-year debenture is anticipated to be 3.12%.

Alternatives Considered	Council may defeat the Bylaw and not proceed with the Range Road 234 reconstruction project until alternative financing options can be explored.								
Implications of Alternatives	<p><u>Strategic Alignment:</u> Operational Excellence – Deferral of the project until alternative financing options can be explored would increase the County’s available debt limit, leaving room for other projects. However, delaying the rehabilitation may result in further deterioration and more expenses in the future.</p> <p><u>Organizational:</u> Administration would not implement the Range Road 234 reconstruction project through the 2022 capital plan.</p> <p><u>Financial:</u> If debt funding is not supported, an alternative funding source, such as a draw from existing reserves, would be necessary.</p>
