Title	Contract Award: Mill and Overlay Works
Proposed Motion	That Council award the contract for the Mill and Overlay Works to Central Civil Solutions Inc. at a contract price of \$689,275.90 (excluding GST) and authorize the Chief Administrative Officer to execute the contract.
Administrative Recommendation	Administration recommends that Council award the contract for the Mill and Overlay Works to Central Civil Solutions Inc., the lowest compliant bidder.

Report	Background Information
	 The 2022 Pavement Preservation Program contract consists of the following road segments (see Attachment 2):
	 Range Road 244 from Highway 37 South to the Sturgeon County limits; and
	2. Starkey Road South portion from Sturgeon Road to the bridge.

	 Tenders for the 2022 Pavement Preservation were posted on Alberta Purchasing Connection (APC) on April 28, 2022 and closed on May 18, 2022.
	• Twelve (12) bids were received, ranging from \$689,275.90 to \$907,300 (see Attachment 1).
	 After reviewing the received tenders, Administration recommends that Council award the contract for the 2022 Pavement Preservation Program to Central Civil Solutions Inc. as they were the lowest compliant bidder.

	 Notifications will be mailed to all affected residents.
	 Construction signage will be placed.

Relevant Policy/Legislation/Practices:

Procurement Policy

- Invitation to Tender is identified as the acceptable method of procurement for construction contracts and other high value procurements.
- Sturgeon County's standard for communicating competitive procurement opportunities is through the Alberta Purchasing Connection.
- Purchases exceeding \$500,000 are to be ratified at the following Council Meeting.

The Chief Administrative Officer shall be signing authority for all Construction or Capital contracts over \$500,000.

Implication of Administrative Recommendation

Strategic Alignment:

Planned Growth – The awarding of this contract is consistent with: *Reliable and effective infrastructure.*

Operational Excellence – The awarding of this contract is consistent with: *Quality cost-effective service delivery; asset management and performance measurement.*

Organizational:

 The awarding of this contract will reduce the maintenance requirements of this road segment thereby freeing up additional capacity to maintain Sturgeon County's service commitment to operational excellence.

Financial:

• The estimated total cost to complete the 2022 Pavement Preservation is \$2,484,417.61. There is currently \$3,050,000 in available funds.
