

**BYLAW 1601/22**  
**AMENDMENT TO BYLAW 1515/20 – AGRICULTURAL SERVICE BOARD BYLAW**  
**STURGEON COUNTY, MORINVILLE, ALBERTA**

---

A BYLAW OF STURGEON COUNTY, IN THE PROVINCE OF ALBERTA, TO AMEND BYLAW 1515/20

**WHEREAS**, section 3 of *Agricultural Service Board Act*, RSA 2000 c. A-10 (the Act) permits Council to establish and appoint members to an agricultural service board;

**AND WHEREAS**, sections 3(2) to 3(6) of the Act regulate the membership and organization of an agricultural service board;

**AND WHEREAS**, Council has passed Bylaw 1515/20 establishing the Sturgeon County Agricultural Service Board;

**AND WHEREAS**, Council deems it desirable to amend Bylaw 1515/20;

**NOW THEREFORE**, the Council of Sturgeon County, in the Province of Alberta, duly assembled, enacts as follows:

**1. Title**

- 1.1. This Bylaw may be referred to as the “2022 Agricultural Service Board Bylaw Amendment”.

**2. Purpose**

- 2.1. The purpose of this Bylaw is to amend Bylaw 1515/22, the Agricultural Service Board Bylaw.

**3. Amendment to Bylaw 1515/20**

- 3.1. Bylaw 1517/20 is amended as follows:
  - a. Revise section 5.1 to read as follows:

“The Board shall consist of two Councillors, six Members who are not Councillors, and one Junior Member.”
  - b. Revise section 5.5 to read as follows:

“Members of the Board who are not Councillors shall serve a 3-year term, except for a Junior member, who is appointed for a 2-year term. Terms shall be staggered to allow for continuity.”
  - c. Revise section 5.6 to read as follows:

“Appointments are for a calendar year, from January 1 to December 31.”
  - d. Delete section 5.7 and renumber the subsequent sections.

- e. In section 9.4, replace “hearing” with “meeting”.
- f. Revise section 10.2 to read as follows:

“Members of the Board who are not Councillors shall be eligible to receive remuneration in accordance with the Board and Committee Public Member Remuneration Policy.”
- g. Delete the footer from page 5 and add the following as section 11.2:

“If any portion of this Bylaw is declared invalid by a court of competent jurisdiction, then the invalid portion must be severed and the remainder of the Bylaw is deemed valid.”

#### 4. Effective Date

- 4.1. This Bylaw shall come into force and take effect on January 1, 2023.
