Title	Contract Award – Township Road 570 Rehabilitation Project – Highway 44 to East of the Alcomdale Hamlet Access
Proposed Motion	That Council award the contract for the Township Road 570 Rehabilitation Project from Highway 44 to East of the Alcomdale Hamlet access to Central Civil Solutions at a contract price of \$929,705.68 (excluding GST) and authorize the Chief Administrative Officer to execute the contract.
Administrative Recommendation	Administration recommends that Council award the contract for the Township Road 570 Rehabilitation Project from Highway 44 to East of the Alcomdale Hamlet access to Central Civil Solutions, as the lowest compliant bidder.

Report	<p><u>Background Information</u></p> <ul style="list-style-type: none"> The Township Road 570 Rehabilitation Project consists of minor regrading, base preparation, and paving. The Project also incorporates drainage improvements identified in the 2022 Alcomdale Drainage Project. Project limits entail 626 meters from Highway 44 to East of the Alcomdale Hamlet access. <p><u>External Communication</u></p> <p>Tendering</p> <ul style="list-style-type: none"> Tenders for the Township Road 570 Rehabilitation Project were posted on Alberta Purchasing Connection (“APC”) and Bids and Tenders on February 23, 2023, and closed on March 17, 2023. Twelve (12) bids were received, ranging from \$929,705.68 to \$1,650,256.50 (excluding GST) (see Attachment 2). Administration reviewed the received tenders for compliance with the tender specifications. Administration is recommending that Council award the contract for the Township Road 570 Rehabilitation Project from Highway 44 to East of

	<p>the Alcomdale Hamlet access to Central Civil Solutions as the lowest compliant bidder.</p> <p>Communications</p> <ul style="list-style-type: none"> Following the contract award and prior to construction startup, a project identification sign will be placed. Notifications will be delivered to all affected residents. <p><u>Relevant Policy/Legislation/Practices:</u></p> <p>Procurement Policy</p> <ul style="list-style-type: none"> Invitation to Tender is identified as the acceptable method of procurement for construction contracts and other high value procurements. Sturgeon County's standard for communicating competitive procurement opportunities is through the APC. Purchases exceeding \$500,000 are to be ratified at the following Council Meeting. The Chief Administrative Officer is the signing authority for all construction or capital contracts over \$500,000.
