<b>Title</b>	<b>Bylaw 1631/23 - Bylaw Enforcement Officer Technical Amendments – First Reading</b>
<b>Proposed Motion</b>	That Council give first reading of Bylaw 1631/23.
<b>Administrative Recommendation</b>	Administration recommends that Council give first reading of Bylaw 1631/23, to allow for the proposed amendments to proceed to a Public Hearing to receive feedback from affected parties.

<b>Report</b>	<p><u>Background Information</u></p> <ul style="list-style-type: none"> <li>Through Budget 2023, Council supported the recruitment of a new Development Compliance Officer position, to bolster the County’s ability to support residents, proactively enforce key development interests (resource extraction, agritourism, etc.), and uphold safety/aesthetics within the community.</li> <li>A review was undertaken regarding enforcement provisions and powers within several of the relevant Sturgeon County bylaws that the Development Compliance Officer is expected to enforce.</li> <li>The review identified several minor amendments to the Land Use Bylaw, Community Standards Bylaw, Civic Addressing Bylaw, and Surface Drainage Bylaw that should be processed to ensure maximum efficiency. The proposed amendments are provided in Attachment 1.</li> </ul>

	<ul style="list-style-type: none"> <li>• While Municipal Violation Tags (tickets) already existed within most of the four bylaws, specific penalties attributed to them were not included.</li> <li>• The proposed amendments include clarifying that the Bylaw Enforcement Officer may enforce the above bylaws, and issue municipal violation tags.</li> </ul> <p><u>External Communication</u></p> <ul style="list-style-type: none"> <li>• Administration will ensure public notification and advertising for the public hearing are completed in accordance with relevant legislation and County processes.</li> </ul> <p><u>Relevant Policy/Legislation/Practices</u></p> <ul style="list-style-type: none"> <li>• Section 7(i) of the <i>Municipal Government Act</i> (MGA) allows Council to authorize enforcement of bylaws</li> <li>• Land Use Bylaw 1385/17</li> <li>• Community Standards Bylaw 1433/19</li> <li>• Civic Addressing Bylaw 1616/23</li> <li>• Surface Drainage Bylaw 1558/21</li> </ul>
<p><b>Implication of Administrative Recommendation</b></p>	<p><u>Strategic Alignment</u>  <b>Operational Excellence</b> – Updates clarify the responsibilities of the Bylaw Enforcement Officer designation and allow flexibility in issuing Municipal Violation Tags instead of only using Provincial Violation Tickets.</p> <p><u>Organizational</u>  Clarifying provisions within the four bylaws allows the Bylaw Enforcement Officer the ability to handle penalties independently without requiring the assistance of other Peace Officers.</p> <p><u>Financial</u>  The municipality collects 100% of Municipal Violation Tag penalty revenue compared to approximately 60% of a Provincial Violation Ticket revenue.</p>
<p><b>Alternatives Considered</b></p>	<p>Council could defeat the Bylaw at first reading.</p>
<p><b>Implications of Alternatives</b></p>	<p><u>Strategic Alignment</u>  <b>Operational Excellence</b> – Officers would rely on Provincial Violation Tickets or referrals to Peace Officers to enforce penalties.</p> <p><u>Organizational</u>  Administration would be required to use multiple enforcement/peace officers to handle the same case work, resulting in lost efficiency.</p> <p><u>Financial</u>  None.</p>
<p><b>Follow up Action</b></p>	<ol style="list-style-type: none"> <li>1. Schedule a Public Hearing prior to second reading of the Bylaw (Planning &amp; Development Services, September 2023).</li> </ol>
