



A Brief Overview Of The Commission




Approximate Population Served By The Commission = 280,000



WATER RATES

The 2024 water rates established by the Commission are as follows:

- Customers who are identified as major or wholesale customers are: Sturgeon County, City of Fort Saskatchewan, Town of Redwater, Town of Bon Accord, Town of Gibbons, Highway 28/63 Services Commission and the John. S. Batiuk Water Commission.
- Wholesale water rates: \$1.6125 per m³ for member municipalities and Hwy 28/63 Water Commission
- \$1.038 m³ for the John S. Batiuk Water Commission.

Water Sales = \$9,376,487.00

Water Meter = 6,329,290 m3

Adjusted Rate = \$1.48/m3
