ASB Mandate

Purpose:

 The Board serves as an advisory body to Council on agriculture-related matters with a goal to promote, enhance, and protect the viability of the agricultural industry in Sturgeon County

Duties and Responsibilities:

- Act as an advisory body and to assist Council and the Minister of Agriculture and Irrigation in matters of mutual concern;
- Advise on and to help organize and direct weed and pest control and soil and water conservation programs;
- Assist in the control of animal disease under the Animal Health Act;
- Promote, enhance, and protect viable and sustainable agriculture with a view to improving the economic viability of the agricultural producer, and
- Promote and develop agricultural policies to meet the needs of the County.

- The Partnership Advisory Committee diligently reviews project proposals on marginally productive or environmentally sensitive agricultural land with the intent of improving ecosystem services and environmental stewardship in Sturgeon County

Duties and Responsibilities:


- Review and approve ALUS projects for agriculture producers based on ALUS principles
- Advise and guide the general direction of the ALUS Sturgeon program
- Establish payment structure and amounts for each selected project
- Appoint technical advisors from external organizations to attend meetings
- Communicate with external organizations and agricultural producers regarding ALUS
- Act as a liaison between Administration, Council, and the agricultural community
- Promote ALUS and environmental conservation in the County
- Hear, collect, record, and act on public feedback where appropriate
- Recommend and participate in the development of projects that align with Sturgeon County strategic outcomes


