



AMENDING AGREEMENT No. 1 FIRE SERVICES AGREEMENT

THIS AMENDING AGREEMENT made as of the _____ day of _____ 2024.

BETWEEN:

STURGEON COUNTY
(the "County")
OF THE FIRST PART

AND:

THE TOWN OF MORINVILLE
(the "Town")
OF THE SECOND PART

WHEREAS the parties entered into an Agreement dated 4 April 2023 (the Agreement), for fire services for January 1, 2023 to December 31, 2026, and;

WHEREAS the parties wish to amend the terms of the Agreement;

NOW THEREFORE, in consideration of the terms of the Agreement and the provisions of the Amending Agreement, the parties agree as follows:

1. The Agreement is amended as follows:

1.1. Town Obligations is amended to add the following:

The Town is responsible for the maintenance of its Self-Contained Breathing Apparatus (SCBA) including those SCBA on County Firefighting Equipment within the Town Fire Hall.

1.2. Section 12, Town Obligations is removed and replaced with the following:

County Firefighting Equipment may be used by the Town from time to time to provide assistance to an incident within the town or another municipality. Where possible, authorization should be sought from the County before County Firefighting Equipment is dispatched. The Town agrees to pay for any use, damages, repairs and or replacement of County apparatus or equipment arising from use while providing assistance to a municipality



other than the County, upon mutual agreement, payable upon invoice from the County.

- 1.3. Section B, Schedule "B", Fees & Contributions is removed and replaced with the following:

The Parties agrees to pay the following per hour rates when fire apparatus is utilized during incidents to transport personnel and equipment. Rates will be adjusted in accordance with the Alberta Transport Rates for Trucks and Command/Support Vehicles. The Ladder Truck will be adjusted at the same percentage as the Trucks. Alberta Transport Rates are typically updated annually April 1st. The County has a 1-month grace period from the published Alberta Transport Rates to adjust payments.

- a. Trucks (Rescue, Tender, Engine including personnel) - \$720.00 per hour minimum and in increments of 15 minutes past the one hour minimum inclusive of wages, fuel, and consumables.
- b. Ladder Truck (Including personnel)- \$1,550.78 per hour minimum and in increments of 15 minutes past the one hour minimum inclusive of wages, fuel, and consumables.
- c. Command/Support Vehicles (Including personnel) - \$210.00 per hour minimum and in increments of 15 minutes past the one hour minimum inclusive of wages, fuel, and consumables.
- d. Trucks (Tender and Engine excluding personnel) – \$505.00 per hour minimum (70% of rate in a. rounded to nearest \$5) and in increments of 15 minutes past the one hour minimum inclusive of fuel and consumables.
- e. All time shall be rounded to the nearest 15-minute increment

- 1.4. Section L, Schedule "B", Fees & Contributions is removed.

- 1.5. Schedule "C", Morinville Fire Service Area, Accepted Proposed Morinville District is removed and replaced with the attached Schedule "C".

2. These amendments shall be incorporated into and form part of the Agreement and Contract Documents effective upon execution of this Amending Agreement by both parties.

3. In all other respects, the Agreement remains unchanged and shall continue in full force and effect throughout the term of the Agreement.

4. This Amending Agreement is binding on the parties and their successors and permitted assigns.

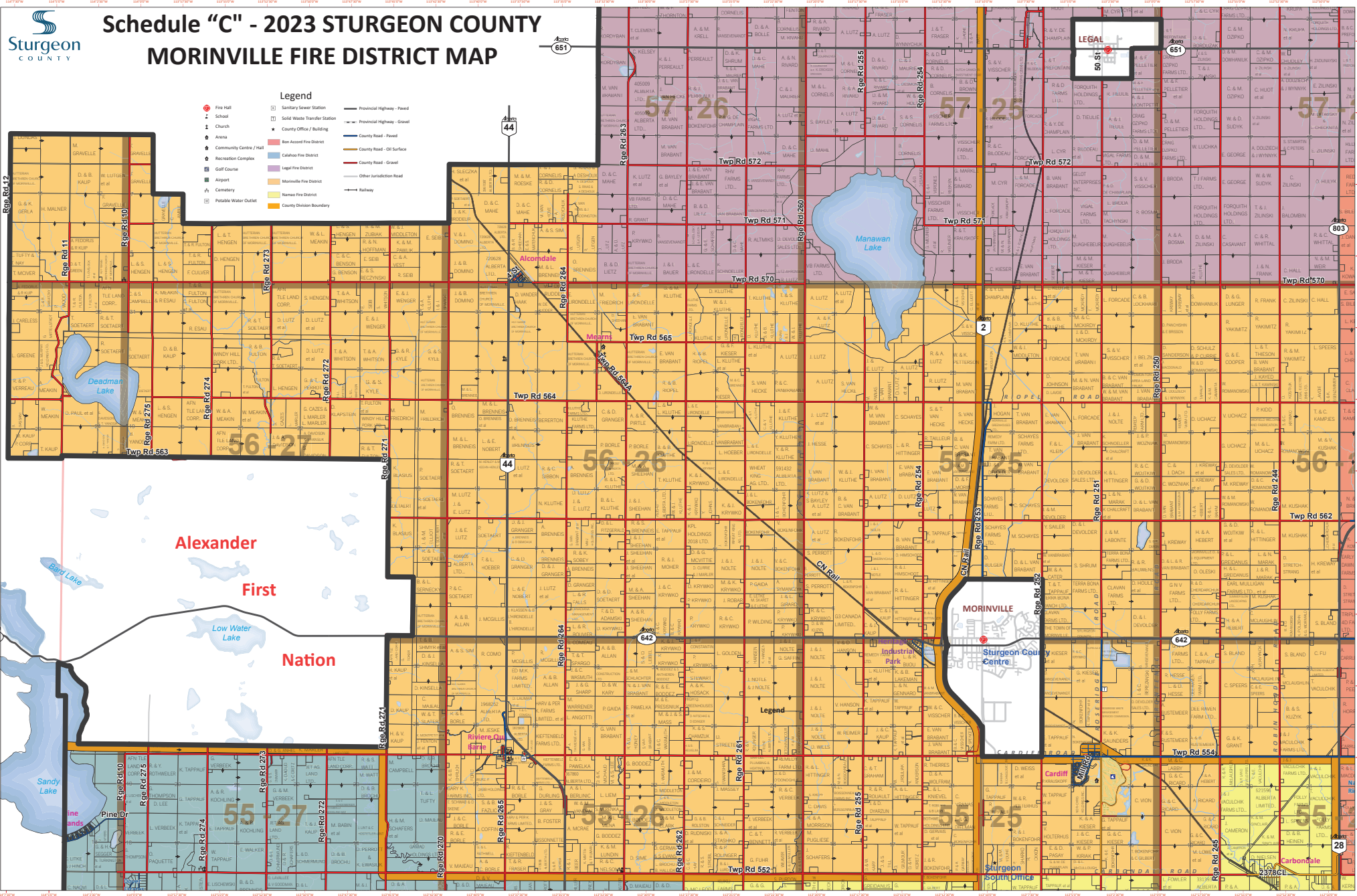
