INTRODUCTION

Throughout 2024, the Safe Communities Facilitator (SCF) achieved significant progress in enhancing public safety, fostering collaboration, and implementing proactive crime prevention strategies. This report showcases objectives achieved and their alignment with Sturgeon County's Strategic Priorities: Safe, Beautiful Communities; Modern, Adaptive Administration; and Economical, Desirable Services. It also outlines organizational enhancements, key stakeholder feedback, and objectives for 2025.

COMMUNITY OUTREACH & PROGRAM DELIVERY

Alignment with Strategic Priorities:

- Safe, Beautiful Communities Programs like Bike Safety Rodeos and Car Seat Clinics improved safety for children and families, while community events fostered trust and unity.
- Economical, Desirable Services Programs were delivered efficiently and tailored to community needs.

Key highlights:

- Bike Safety Rodeos Educated over 150 children through two events focusing on helmet use, bike maintenance, and safe riding practices.
- Car Seat Clinics Conducted two clinics at Protective Services Headquarters, ensuring proper installation and usage of 12 child safety seats for parents/caregivers.
- Coffee with a Cop Hosted informal gatherings in Pinewood, Redwater, Calahoo, Coronado, Villeneuve, Legal, and Rivière Qui Barre to build trust between residents and law enforcement.
- Community engagement Participated in 13 local events to promote safety initiatives and introduce the Safe Communities Facilitator role.
- Wellness on Wheels and County Bounty Actively engaged in six Wellness on Wheels events to promote crime prevention and safety education.

Enables regular community connections and education of the public.

Key initiatives:

- Ride-alongs Conducted eight ride-alongs to gain insight into community safety challenges.
- Touchpoints with Detachment Commanders Met 12 times to address crime trends, establish clear processes, and facilitate collaborative strategies.
- RCMP engagement Assisted with standardizing Council presentations and facilitated four RCMP Priority Meetings.
- Collaboration with RCMP K Division Partnered with the Community Safety and Wellbeing Branch to enhance and develop new initiatives.

CRIME PREVENTION & SAFETY EDUCATION





Alignment with Strategic Priorities:

Key programs:

- Crime prevention sessions Conducted five sessions to enhance local safety awareness.
- Internet Child Exploitation Facilitated a presentation delivered by Alberta Law Enforcement Response Team to over 20 parents/guardians.
- CPTED Introduced a safety assessment program, including meetings with three businesses to discuss implementation.
- Student safety programs Facilitated the education of over 300 students on the dangers of distracted driving and over 200 students in Cyberbullying and Online Safety Awareness.

Alignment with Strategic Priorities:



Key collaborations:

- Support for community groups Worked with the Sturgeon Rural Crime Watch Association and Citizens on Patrol groups, meeting with community groups over 30 times to discuss and implement initiatives.
- Conference participation Represented Sturgeon County at the Alberta Community Crime Prevention Association Conference, fostering networking and knowledge sharing.
- Internal collaboration Partnered with County departments to enhance service delivery and presented in collaboration with Ag Services at the Environmental Planning Workshop and Shelterbelt Planning Workshop.
- Intermunicipal collaboration Some municipalities have adopted similar Safe Communities Facilitator positions since the introduction of Sturgeon County's role, with a few reaching out to Sturgeon County for guidance.
- Digital collaboration Worked with Corporate Communications to review and update the Crime Prevention and Safe Communities pages on the County website.
- Division engagement Participated in all six County divisions on 71 occasions, delivering educational sessions, hosting events, and engaging with residents and key stakeholders.
