AND WHEREAS pursuant to the provisions of the *Municipal Government Act*, RSA 2000, c M-26, and amendments thereto, STURGEON COUNTY has the authority to acquire a fee simple estate or any other interest with respect to the Lands by expropriation;

AND WHEREAS a Notice of Intention to Expropriate the Lands has been filed in the Alberta Land Titles Office and due notice has been served upon all persons required to be served, and due notice has been published in a newspaper having general circulation in STURGEON COUNTY, all in accordance with the provisions of the *Expropriation Act*, RSA 2000, c E-13, as amended (the "*Expropriation Act*");

AND WHEREAS the Council of STURGEON COUNTY before enacting this Resolution has given due consideration to the fact that service of the Notice of Intention to Expropriate was effected on the registered landowners through service on its legal counsel, registered mail and publication that was effected on January 30, 2025 and February 13, 2025 in the St. Albert Gazette;

AND WHEREAS no objections to the Notice of Intention to Expropriation were filed with the County and that the registered landowner, the Sturgeon Valley Golf and Country Club, have entered into a Section 30 Agreement with the County, dated February 4, 2025, indication that the Sturgeon Valley Golf and Country Club does not object to the expropriation and agrees to certain compensation and mitigating measures to be undertaken by the County;

NOW THEREFORE BE IT RESOLVED:

1. THAT the expropriation of a fee simple interest and temporary working easement in the Lands, legally described as follows:

- 2. THAT the portion of the Lands being expropriated for a fee simple interest shown on the plan that is attached as Schedule "A" to this Resolution is approved.
- 3. THAT the portion of the Lands being expropriated for a temporary working easement shown on the plan that is attached as Schedule "B" of this Resolution is approved.

4. THAT the expropriation of the fee simple interest and temporary working easement in the Lands are approved for the following reasons: for construction, operation, and maintenance of a pedestrian trail,

bridge, and related improvements.

5. THAT the officers, servants or agents of STURGEON COUNTY are hereby authorized and empowered to

sign and seal the Certificates of Approval and its officers and solicitors are further authorized and

empowered to sign and seal all other documents and plans and to carry out all necessary acts required by

the Expropriation Act or otherwise in order to complete this expropriation.

6. THAT officers, servants or agents of STURGEON COUNTY and the solicitors for STURGEON

COUNTY are hereby authorized and empowered to make a proposed payment pursuant to the provisions

of the Expropriation Act and the Section 30 Agreement to the owners of the said Lands, or such

compensation as may be ascertained and determined by the Land and Property Rights Tribunal, or as may

be agreed upon between STURGEON COUNTY and the respective owners.

7. THAT the officers, servants or agents of STURGEON COUNTY and the solicitors for STURGEON

COUNTY are hereby authorized and directed to do all things necessary to obtain possession of the Lands.


