In 2021 Four Tracks applied for rezoning to Direct Control (DC-11) on the advice from Sturgeon County as we were not compliant with Sturgeon County bylaws. Martyn Bell has been assisting with our application along with Carla Williams. Four Tracks has implemented the county's recommended changes. We have also planted more than 150 trees along with several flower gardens.

Sturgeon County recommended changes were to decrease the area our company equipment was currently stored due to environmental issues such as coal seams and mining operations in the past.

The county also requested;

- Length of time our company has been in business,
- The amount of employees,
- Hours of operation,
- Nuisance factors (smoke, noise, dust etc.) generated
- Routes taken when going off-site

The recommended area for use by Sturgeon County is presented in the arial photo highlighted in blue.



## Four Tracks All Terrain Ltd

Is an off-road transportation company located in Carbondale, Alberta. The company has been in business since 2004 and located in its current location since October 2009.

All company work is conducted off-site at various locations throughout the province, with only maintenance on the company vehicles being done in the shop located in Carbondale. Four Tracks employs 2 technicians at the Carbondale shop all other employees are employed off-site at various job locations.

Our hours of operation are 9am to 5pm Monday to Friday with exceptions for emergency response.

In 2020 business was decreased considerably do to COVID and 2021 Four Tracks had less then 50 days work performed in shop and 18 days fighting fires north of Fort McMurray.





• Four Tracks made the recommended changes and decreased the allowable area further then required. Any unnecessary vehicles or equipment were sold off to further reduce the company footprint. Company trucks are now located on the outer wall of the shop with the remainder of vehicles and equipment located to the rear of the shop. Exhaust ventilation and dust fans are located to the rear of the shop with not impact of noise or dust to our neighbors. Vehicles heading off site our transported west of Carbondale on Twp Rd 552 then south on range Rd 250 to highway 37 or directly west on Twp Rd 552 to highway 2 North depending on the job location.

The Bombardier Snowcats have an even lighter footprint making these vehicles environmentally desirable to use.
